BRITISH SHIVLING EXPEDITION
1988

OBJECTIVE

During September 1986, myself, Owain Jones, Scott Umpleby and Steve Wallis began to plan a climbing trip to the Garwhal Himalaya. At that stage our objective was unclear. Following the publication of several documents, we decided to apply for permission from the Indian Mountaineering Foundation to climb, by its ordinary route (W. ridge), Shivling (6543m), a mountain lying at the juncture of the Meru and Gangotri Glaciers in the Garwhal Himalaya.

Permission to climb the route was not granted, as it was fully booked. As an alternative, we decided to go out there anyway and climb small peaks of no great altitude or significance.

Several weeks later, I met up with Mike Searle's team, who were intending to go to Shivling at the same time. Their objective being to climb the N.W. ridge - a new route.

It was suggested to us that we should go out with them, thereby reducing costs and enabling us to use only one Liaison Officer. The arrangement being that we climb as to autonomous groups, on arrival at the mountain.


After some thought - we agreed. The route would be quite a struggle but would allow us to gain some valuable know-ledge, being in the company of climbers with so much valuable experience on big mountains.


Dr Mike Searle then proceeded to book the peak and for organisational purposes, took up the role of overall leader of the joint teams.

The objective of the expedition being to climb Shivling (6543m) by a new route - the N.W. ridge.

first hint of light. Followed a couple of hours later by S Umpleby and O Jones.

7th October: Decision made to retreat from mountain

due to J Robertson's unhappiness with his medical condition and also the unconsolidated snow on the ridge combined with our overall lack of

experience on big mountains.

Unanimous decision to walk out from

mountain.

8th October: March out.

9th October:

Bus from Gangotri to Uttarkachi.

10th October:

Bus from Uttarkachi to Delhi.

15th October: Return to U.K.

WEATHER CONDITIONS

Immediately prior to our arrival at Tapovan (Base Camp), there was a period of considerable precipitation, presumably the tail end of the Monsoon. This led to considerable floods in the villages on our approach. At Tapovan, the precipitation manifested itself as snow. Immediately following this period came a ridge of high pressure, giving crystal clear skies, but very low temperatures. At Tapovan we recorded temperatures of - 15°C during the evening. At our high point of around 18,000ft, we recorded a temperature of - 25°C at 0200 hours.

The extreme low temperatures meant that the snow that had fallen during the period of precipitation remained unconsolidated, rendering the route, which we hoped would consist of mixed climbing, to be particularly dangerous. We witnessed several avalanches from our intended route.

For these reasons stated, combined with our general lack of experience at this altitude, we came to the conclusion that a retreat was our safest option.

ILLNESS


Everyone in the team showed symptoms of sub-acute mountain sickness at Tapovan. For approximately three days, Jim Robertson complained of a pain in the region of his liver. After five days acclimatization, most people's symptoms had virtually disappeared.

A decision was made to attempt an ascent of the peak. At around 16,000ft Steve Wallis had to retreat, complaining of chest pain. The remaining three climbers continued up the Meru Glacier for another four hours to an altitude of around 18,000ft. A bivvy site was excavated and they settled down for the night. At about 2200 hours, Jim Robertson developed a severe headache, by around midnight, this headache had worsened and he was showing signs of cheyne stokes breathing and also, complaining of chest pain. At around 0400 hours, he packed away his sleeping bag and retreated. Scott Umpleby complained of similar problems and was forced to retreat along with Owain Jones. On arrival at Tapovan, Jim Robertson's symptoms improved dramatically, as did Scott Umpleby's.

On the team's return to the U.K., a medical examination of Jim Robertson revealed a considerable quantity of fluid in his lungs, and also the medical opinion was that his pain experienced at Tapovan, could have been a minor pulmonary embolus.
